SUM INSURED:	Up to GBP 1,000,000 per Claimant, subject to and in accordance with the limits and the terms and conditions of the Policy.
RETENTION:	Minimum of GBP 85,000 per Claimant and if greater, an amount equal to all payments paid or due to the Claimant, from the FSCS, the Insured's Estate or any other source in respect of the Claimant's Loss.
